**[PROPOSED] ORDER**

Pursuant to the stipulation of the parties and for good cause shown,

IT IS ORDERED that defendant Joseph Giraudo pay restitution totaling \$206,466.11, payable to the victims specified as “Successor in Interest/Trustee” in the chart attached to the stipulation as Exhibit A. Restitution must be paid in full no later than 15 days from the entry of this Order. Any established payment plan does not preclude enforcement efforts by the Department of Justice if the defendant has the ability to pay more than the minimum due. The restitution payments shall be made to the Clerk of U.S. District Court, Attention: Financial Unit, 450 Golden Gate Ave, Box 36060, San Francisco, CA 94102.

IT IS FURTHER ORDERED that the restitution hearing scheduled for June 1, 2018 is vacated.
