20 The defendant, Homy Hong-Ming Hsu, represented by Becky Walker James, appeared
21 before Magistrate Judge Cousins on August 12, 2011, for initial appearance, arraignment, and a
22 detention hearing and also appeared before Judge Seeborg on August 23, 2011 for a status
23 conference and an initial appearance.


24 The defendant and the government make a joint request to exclude time under the Speedy
25 Trial Act between August 23, 2011 and March 5, 2012, for effective preparation of counsel to
26 allow defense counsel time to review discovery and to conduct necessary investigation to prepare
27 for trial. The defendant and the government agree that failing to exclude the time between
28 August 23, 2011 and March 5, 2012 would unreasonably deny the defendant and his counsel the


1 reasonable time necessary for effective preparation, taking into account the exercise of due
2 diligence. 18 U.S.C. § 3161(h)(7)(B).

3 The defendant and the government agree that the ends of justice served by excluding the
4 time between August 23, 2011 and March 5, 2012 from computation under the Speedy Trial Act
5 outweigh the best interests of the public and the defendant in a speedy trial.
