1 **NOTICE OF MOTION AND MOTION**

2 **TO THE PARTIES AND THEIR ATTORNEYS OF RECORD:**

3 **PLEASE TAKE NOTICE** that on October 1, 2009, at 4:00 p.m., or as soon thereafter
4 as the matter can be heard, before the Honorable Susan Illston of the United States District
5 Court, Northern District of California, 450 Golden Gate Ave., San Francisco, California,
6 Indirect-Purchaser Plaintiffs will and hereby do move for class certification pursuant to Rule 23
7 of the Federal Rules of Civil Procedure.

8 The Indirect-Purchaser Plaintiffs seek certification of a nationwide class (the
9 “Nationwide Class”) for injunctive relief pursuant to Fed. R. Civ. P. 23(b)(2) defined as
10 follows:

11 All persons and entities residing in the United States as of the date notice
12 is first published, who indirectly purchased in the United States between
13 January 1, 1999 and the present LCD panels incorporated in televisions,
14 monitors, and/or laptop computers, from one or more of the named
15 Defendants, for their own use and not for resale. Specifically excluded
16 from this Class are the named Defendants; the officers, directors, or
17 employees of any defendant; any entity in which any defendant has a
controlling interest; and any affiliate, legal representative, heir or assign
of any defendant. Also excluded are any federal, state, or local
governmental entities, any judicial officers presiding over this action,
members of their immediate families and judicial staffs, and any juror
assigned to this action.

18 In addition, the Indirect-Purchaser Plaintiffs move to certify the following state classes
19 (the “Indirect-Purchaser State-Wide Classes”) for damages pursuant to Fed. R. Civ. P. 23 (b)(3)
