The Court agrees with Plaintiff that information relating to negotiations with airlines, going back to 2005, is within the broad scope of relevance for purposes of discovery, as such information may lead to discovery of admissible evidence as to the potential future anti-competitive effect of the proposed merger. Defendants' own representations (detailed in Plaintiff's letter) stretch back to at least 2006 and provide a context which the Court may (as factfinder) deem relevant to issues it will have to decide at trial. While the Court is not at all persuaded that the requested information is irrelevant, the Court is concerned that some amount of what Plaintiff seeks would impose an undue burden on Defendants (and the amount of additional burden the Court should impose on Defendants consistent with proportionality is unclear). Accordingly, IT IS FURTHER ORDERED that the parties shall meet and confer and shall, no later than November 20, advise the Court as to whether (now that the Court has overruled Defendants' relevance objection) they can agree on what Defendants must produce - and, if not, how they propose the Court resolve any remaining dispute. As for Defendants' request, the parties Joint Stipulations Regarding Discovery prohibit either party from requesting "a recitation of information contained in [interview] notes or memoranda." (D.I. 31 Ex. 1 at 6(e)) The Court agrees with Plaintiff that "Defendants explicitly agreed not to seek this information" and "both the letter and spirit of the parties' agreement entered by the Court was to shield from discovery the information contained in the interview notes and memoranda." (D.I. 145 at 1) While the Court need not decide whether granting Defendants' request would also invade work product protection, the Court understands that one of the reasons Plaintiff included paragraph 6(e) was to avoid this particular threat to what it views as protected work product. Additionally, Defendants have failed to persuade the Court that they could not obtain the same information through other means, including third-party subpoenas. ORDERED by Judge Leonard P.
