1	Now pending before the Court is a Joint Motion to Continue the Evidentiary Hearing
2	Regarding Plaintiff's Motion for a Preliminary Injunction (Dkt. 109), and the hearings for all
3	related motions—i.e., Plaintiff's Motion to Strike (Dkt. 95) and Plaintiff's Motion in Limine
4	(Dkt. 171)—pursuant to the Federal Rules of Civil Procedure and Local Rule 7-7 of the
5	Northern District of California. After consideration of the Motion and all other matters
6	presented to the Court, and in light of the parties' discussion of a potential resolution of the
7	current matter resulting from Defendants Intercontinental Exchange, Inc. ("ICE") and Black
8	Knight, Inc.'s ("Black Knight") announcement of the planned divestiture of the Optimal Blue
9	business (including the Optimal Blue PPE), and the need for FTC staff to analyze the
10	implications of the divestiture for this case and the parallel administrative proceedings and
11	advise the FTC Commissioners, IT IS HEREBY ORDERED that the Joint Motion to Continue
12	the Evidentiary Hearing Regarding Plaintiff's Motion for a Preliminary Injunction (Dkt. 109),
13	and the hearings for all related motions—i.e., Plaintiff's Motion to Strike (Dkt. 95) and
14	Plaintiff's Motion in Limine (Dkt. 171)—is GRANTED. The pre-hearing conference, and
15	hearings for Plaintiff's Motion to Strike and Motion in Limine, will be rescheduled to August 9,
16	2023 and the evidentiary hearing will be rescheduled to August 14-16, 2023.
