Natl Childrens Ctr., Inc., 98 F.3d 1406, 1409 (D.C. Cir. 1996) ([T]he starting point in considering a motion to seal court records is a strong presumption in favor of public access to judicial proceedings. (quoting Johnson v. Greater Se. Comty. Hosp.
