Whole Foods Market, Inc. (“Whole Foods”) respectfully requests leave to file a Reply in support of its Petition for Rehearing *En Banc*. The Panel opinion represents a regrettable and dramatic departure from modern antitrust analysis and the standards for granting preliminary relief, which opens the door for questionable and speculative intervention by the FTC to halt free-market activity without a sound economic foundation. In its Response to the Petition for Rehearing *En Banc*, the FTC abandons economic principles and inaccurately characterizes this Court’s prior decisions and the Panel opinion, all in an apparent attempt to minimize the significance of the legal changes wrought by the Panel opinion. A reply brief is necessary to correct the record and reduce potential confusion about the foundations for and implications of the Panel opinion. Whole Foods’ Reply concisely addresses the issues, and is only ten pages long.


