 Let me share my "preliminary" price target for Mar. with you as just your reference. Hope this is help for you to draft up AUO's proposal to HP for Mar. business. As Mar. price target is approaching the break-even price, I don't think Apr. price would go down a lot except 17" Wide LCD. I still believe 17"W panel price should be much lower than current level in Q2.

Dear All,

Update some market infomation as follows.

1. SEC/JK Kim said SEC VD got demand upside from Jan'06 since they cut down \$20 for LCD MNT set. And, they may get \$30M loss for LCD monitor business in Jan'06. So, they ask vendor to understand their situation and support them with aggressive price.
2. SEC/BG said AMLCD offer \$137 for 17" and \$177 for 19", but BG are not satisfied with this price proposal because he think Dell get around \$7~\$8 price support in Feb and expect their vendors to support them with same price reduction.

[Shaders Lin 林靜美]

- SEC's MNT SET Price

17"-->\$349-->\$349
19"-->\$399-->\$379

- SEC ask AMLCD \$138 for 17" and \$178 for 19". But, AMLCD would like to keep 19" above \$180 at least.
- HSD \$175 for 19", but only for SEC. For others, the price still keeps around \$180-185.

3. SEC/BG said they are buying 200k/m 19" from HSD and SEC VD are trying to reduce AMLCD's portion, so he can support 19" volume upside to 100k or even 130k in Feb if we can support SEC VD with competitive price. As for 17", he mentioned the possibility for demand upside is small relatively. But I think it does not make any sense if HSD and AMLCD can support them with more volume and aggressive price in the upcoming months.

- It's true that SEC took 19" ~200k/m at \$175 from HSD.

4. SEC/BG mentioned LPL's G7.5 is not as smooth as expected and LGE people mentioned their Sales team are requesting 42" LCD TV, but they can not deliver now. And that is quite in line with Tony's information that LPL are cutting their 17" volume in Feb and Mar. (Please check with LPL's move)

[Shaders Lin 林靜美]

- LPL's G7.5: slowly ramping up on schedule. ~10-15K/200602.
- As we mentioned in our Jan's report, LPL have already decided to shift MNT capa to TV by dropping 17" and increasing TV 37"/32" in G6. 17"=>650K/200501, 790K/200502.
- LPL is now considering to build G 5.5.

5. I heard that BOE-Hydis are shifting their 17" capacity to TV 20"VGA(100k/m), and now they are 20.1"TV price killer. SVA are also shifting their capacity to small-size TV.(Shaders help to check it!) [Shaders Lin 林靜美]

- BOE: ~20"VGA \$205 ; volume ~80K /200512.
- 100K/M is expected in Jan'06. They intend to do max. 200K/M later on.
- SVA will MP 20"VGA in Jun'06 as well.

6. LGE people mention their demand in Jan'06 is as same as that in Dec, but they got 1 month inventory for LCD monitor sets in Hubs now. As LGE/Mr. Huang mentioned that they are trying to make 60% outsourcing(from 40% now) happened for LCD monitor panel in 2006. It also does not make any sense now if LPL can support them with volume and price at this moment.

幾件市場訊息, 好壞都有, 提供一下參考:

1. 奇美第四季 array/cell全開, 同時也因為折舊攤提降低, 第四季利潤率會很好, 但從一月開始, 他們的主要客戶 (monitor部份)銷售皆不佳, 造成現在的存貨超過 "一個月"以上. 在元月底的時候, 已經對宏碁 17"出價 \$135, 但宏碁的銷售也超爛, 所以, 也拿不動. 另外, 從這點, 也可以瞭解到為什麼奇美幾乎都把所有的cell全部塞在唯冠了.
2. 宏碁元月不但低於 600k, 另一說法是不到 500k, 猜測僅有 450~500k 之間, 二月可見度甚至僅 300k, 跟他們在去年第四季動輒超過 800k簡直算壞透了. 這個訊息, 對於主流市場的尺寸, 恐怕是另一個殺戮的開始.
3. 奇美 17" < \$140 會虧.
4. LPL: 除先前將 19"數量下壓之外, 計劃在第一季再將 17"從原先的 1000k降至三月底時 500~600k/m的水位.
5. 華映的元月銷售中, monitor 記帳 (寄倉) 約 450k (近 40%).
6. 歐洲的一般 channel市場看起來有在恢復, 所以唯冠/代理商的銷售不錯 (或許這也是三星不錯的原因), 但相對的, 品牌銷售爛到可以, FSC第一季不買都還夠用, 宏碁的情況上面說了, 這就讓人很納悶, 平平都是monitor, 為什麼會差那麼多?

大概就醬子, 還有新的消息再連繫

Dear all,

I talked to CMO Sales person today. Following are some information from CMO for your reference. Pls let me know if you have any questions.

1. CMO used to support 12.1" and 14.1" for iBook and PowerBook. However, Apple requested to stop shipment suddenly from this month.

Currently, 15.4" and 13.3" are the only two projects working with Apple.

2. Apple did stop Samsung's 15.4" shipment at the beginning due to an inverter issue caused from system side. Up to now, Samsung already

shipped around 100K and CMO also started shipping from Feb.

3. Apple is also pushing CMO to increase volume to 100K/M for M1 but CMO doesn't really think 100K per month for one supplier is realistic.

Their target is 50K~70K shipment per month.

4. It is believed that Samusng's Feb. price is around \$165. The Sales person said CMO's Feb. price is \$162. Their current idea is to drop a few

dollars per month over following two or three months. But hope to keep at least \$160 for March at this point. However, it's not a final number

since Priya is still pushing.

5. In CMO's original M1 proposal, they committed to Apple only add up \$20 on conventional 15.4" market price as M1 price; however, they realized

actual cost at the beginning is actually higher than original estimation.

6. In CMO's original M42 proposal, they commited to Apple to follow 14.1" market price as 13.3" quote. Now, Apple is asking \$120 for 13.3" as NTE

in April since 14.1" price is dropping significantly in the market place and LPL seems to be able to offer this price. CMO said LPL makes 13.3"

and 14.1" in G5 fab.





Yesterday, I visited AMLCD to know the AMLCD NB policy.

Basically, AMLCD NB price is reached to cash cost already. Especially, both 14.1"W and 15.4"W are already under cash cost now.

Therefore, AMLCD decided to maintain June price to July and due to keep the price, if customer reduce the demand, he shall reduce the production.

AMLCD intentionally does like this to make his customer surely know that this is bottom price of both sizes.

Actually, i met Harry Cho who was working for SEC Taiwan branch office before, after he came back he is charging HP, Lenova, Apple accounts.

As i reported before, Harry got only 10K 15.4"W order from HP even though he quoted U\$ 85 last week.

According to his mentioned, HP got 6 weeks panel inventory now. Because of long term biz agreement with LPL, HP purchased 400k from LPL in this month.

He supposed that if HP requests LPL to drop 15.4"W price to U\$ 80, LPL may follow this price again. But AMLCD will not follow this price and just reduce the production according to demand reducing.

It may impact to 70% production for NB only in July. But AMLCD will endure this situation to maintain the current price.

In contrary , he will try to raise the price with strong demand products from July slightly.

He hopes AUO also follow AMLCD's strategy and make customer know our painful situation.


Someone told me that from '06 Q4, NB demand will pick up due to new Window OS is coming. But MNT will not be impacted by this event. Therefore, MNT may be shown the dropping curve in '07 but NB demand may possible revive.

In May LPL sold 1.45M panels of NB, but AMLCD only sold 1.4M.

In June, AMLCD expects to sell 1.5M and Monitor : 2M, TV : 1M.
