THAT JUDGMENT IN THE ABOVE ENTITLED CAUSE IS ENTERED IN FAVOR OF PLAINTIFFS, BLUE CROSS BLUE SHIELD OF MASSACHUSETTS, BLUE CROSS BLUE SHIELD OF MINNESOTA, FEDERATED INSURANCE COMPANY, AND THE HEALTH CARE SERVICE CORPORATION, AGAINST DEFENDANTS, MYLAN LABORATORIES INC./MYLAN PHARMACEUTICALS INC., CAMBREX CORPORATION, AND GYMA LABORATORIES.

BLUE CROSS BLUE SHIELD OF MASSACHUSETTS IS AWARDED: \$7,424,878.00 IN COMPENSATORY DAMAGES, PLUS PREJUDGMENT INTEREST OF \$6,213,184.54, RECOVERABLE FROM MYLAN LABORATORIES INC./MYLAN PHARMACEUTICALS INC., CAMBREX CORPORATION, AND GYMA LABORATORIES JOINTLY AND SEVERALLY; AND \$14,849,756.00 IN PUNITIVE DAMAGES RECOVERABLE FROM MYLAN LABORATORIES INC./MYLAN PHARMACEUTICALS INC. INDEPENDENTLY; \$14,849,756.00 IN PUNITIVE DAMAGES RECOVERABLE FROM CAMBREX

CORPORATION INDEPENDENTLY; AND \$14,849,756.00 IN PUNITIVE DAMAGES RECOVERABLE FROM GYMA LABORATORIES INDEPENDENTLY.

BLUE CROSS BLUE SHIELD OF MINNESOTA IS AWARDED: \$3,605,301.00, PLUS PREJUDGMENT INTEREST OF \$281,526.96.

FEDERATED INSURANCE COMPANY IS AWARDED: \$1,232,634.00, PLUS PREJUDGMENT INTEREST OF \$96,167.97.

HEALTH CARE SERVICE CORPORATION IS AWARDED: \$3,857,352.00.
