**COMCAST’S RESPONSE TO PLAINTIFFS’ MOTION
FOR CERTIFICATION OF A SETTLEMENT CLASS AND
PRELIMINARY APPROVAL OF CLASS ACTION SETTLEMENT**

Defendants Comcast Corporation, Comcast Holdings Corporation, Comcast Cable Communications, Inc., Comcast Cable Communications Holdings, Inc., and Comcast Cable Holdings, LLC (collectively “Comcast”) respectfully submit this response in connection with Plaintiff’s Motion for Certification of a Settlement Class and Preliminary Approval of Class Action Settlement filed on October 28, 2014 (ECF No. 608) (the “Motion”).

Comcast confirms that it does not oppose the Motion. However, Comcast does not necessarily agree with or adopt Plaintiff’s characterizations of fact and law in the Motion and in the accompanying Memorandum in Support of Motion for Certification of a Settlement Class and Preliminary Approval of Class Action Settlement (ECF No. 608-1) (the “Memorandum”). Comcast’s non-opposition is for settlement purposes only and will have no force or effect if the Settlement is not approved. Comcast expressly reserves all rights to dispute Plaintiff’s characterizations of fact and law in the Motion and Memorandum in the event that the proposed Settlement is not approved or in any other action or proceeding to which Comcast is, or may become, a party.
