**FEDERAL TRADE COMMISSION’S
MOTION FOR ENTRY OF JUDGMENT**

Pursuant to Fed. R. Civ. P. 58(d), plaintiff Federal Trade Commission (“FTC”) requests that the Court enter judgment in the above captioned case.

1. On February 22, 2010, this Court entered an order in *In re Androgel Antitrust Litigation (No. II)*, MDL Docket No. 2084, 1:09-MD-2084-TWT, in which it ruled on motions by defendants for dismissal of plaintiffs’ claims in various actions. *See* Order, MD Dkt. 50, Feb. 22, 2010 (“Feb. 22 Order”).

2. The Court granted those motions in part, and denied them in part. Defendants’ motions to dismiss were denied only with respect to certain claims made in private actions filed by the “direct purchasers.” *See* Feb. 22 Order at 9-10,

24-25. The motion to dismiss all claims of the FTC was granted. *Id.* at 24. Under these circumstances, proceedings in this Court on the FTC's action are at an end.

3. Subject to exceptions not relevant here, Fed. R. Civ. P. 58 directs that “[e]very judgment and amended judgment must be set out in a separate document * * * .” The FTC therefore requests that the Court enter the judgment in a separate document. Defendants do not oppose this request.
