		<p><u>First</u>, the plaintiffs answered Interrogatory Number 1 with an objection, stating the interrogatory seeks “information conveyed”—or “facts”—from persons who were interviewed in the course of the pre-suit investigation, but upon whom the plaintiffs do not intend to rely at trial. Both parties support their position as to this interrogatory by pointing to reasoned decisions resolving similar disputes in analogous situations. Having considered those decisions and the facts presented here, the Court ALLOWS in part and DENIES in part the defendants’ motion to compel a further answer to Interrogatory Number 1.
