NOTICE OF RELATED CASE AMAZON.COM, INC., a corporation, 11 12 Defendant. 13 14 Pursuant to Local Civil Rule 3(g)(1), Plaintiffs Federal Trade Commission ("FTC") and states of New York, Connecticut, New Hampshire, Oklahoma, Pennsylvania, Delaware, Maine, Maryland, Massachusetts, Michigan, Minnesota, Nevada, New Jersey, New Mexico, Oregon, 16 17 Rhode Island, and Wisconsin, acting by and through their respective Attorneys General 18 (collectively, "Plaintiffs"), submit this notice of the following related case: Zulily, LLC v. 19 Amazon.com, Inc., 2:23-cv-01900 (W.D. Wash.) ("Zulily"), filed on December 11, 2023. Zulily 20 is currently before Judge Barbara J. Rothstein. 21 Zulily, an online retailer, describes itself as "one of Amazon's victims." Complaint, 22 Zulily, LLC v. Amazon.com, Inc., No. 2:23-cv-01900 (W.D. Wash. Dec. 11, 2023), Dkt. #1 at 1. 23 24

Zulily alleges that "[a]fter only a few months of being targeted by Amazon's exclusionary conduct," it "was forced to discard the 'Best Price Promise' it made to consumers and to remove all Amazon price comparisons from its website—effectively abandoning its strategy to gain scale through discount pricing." *Id.* at 2. Zulily further alleges that Amazon's "conduct has caused Zulily substantial revenue losses and reduced traffic to Zulily's website," and "denies Zulily the scale necessary to compete in the market." *Id.* at 2-3. Zulily brings claims for violations of Section 1 and Section 2 of the Sherman Act, Washington Antitrust Law, and Washington Unfair Competition Law.

Like Plaintiffs in this case, Zulily alleges that Amazon denies shoppers lower prices by punishing sellers who offer lower prices off Amazon. *See, e.g.*, Complaint, *FTC, et al.*, *v. Amazon.com, Inc.*, 2:23-cv-01495-JHC (W.D. Wash. Sept. 26, 2023), Dkt. #1 at 83-87.

However, Plaintiffs challenge that conduct under Section 5 of the FTC Act and numerous state laws not at issue in *Zulily*. Plaintiffs also challenge Amazon conduct that is not at issue in *Zulily* under both federal and state laws.

Plaintiffs' case differs from and is broader than *Zulily*. However, Plaintiffs' case involves certain overlapping factual and legal issues with *Zulily*. Plaintiffs' case and *Zulily* address some of the same conduct engaged in by Amazon, and Plaintiffs' case and *Zulily* concern many of the same transactions and events, including certain of the restrictions Amazon imposes on sellers. Accordingly, it is "likely that there will be an unduly burdensome duplication of labor and expense or the potential for conflicting results if the cases are conducted before different judges." Local Rules W.D. Wash. LCR 3(g)(4).
