ORDER

This matter comes before the Court upon Plaintiff's Motion for Leave to File a Surreply in Opposition to Defendant Amazon.com, Inc.'s Motion to Dismiss Amended Complaint, filed February 1, 2022.

Plaintiff seeks leave of Court to file a sur-reply because "[i]n its Reply, Amazon raises the new argument that the District failed to properly plead the application of a *per se* standard of review to the District's restrain [*sic*.] of trade claims." Pl. Mot. at 1. Plaintiff contends that Defendant "attempts to raise an issue regarding the *per se* pleading standard for the first time." *Id.* When parties conferred, Defendant reported that "Amazon takes no position on this motion but maintains that it has not provided new arguments in its reply and reserved its rights to seek leave for a sur-reply." *Id.* at 2. Upon review of the record, and without objection, the Court will accept Plaintiff's brief sur-reply for filing.

Accordingly, it is this 10th day of February 2022, hereby:

ORDERED that Plaintiff's Motion for Leave to File a Surreply in Opposition to Defendant Amazon.com, Inc.'s Motion to Dismiss Amended Complaint is **GRANTED**; and it is further

ORDERED that Plaintiff's sur-reply is deemed filed; and it is further

ORDERED that the Scheduling Conference Hearing currently scheduled on February 11, 2022 is **continued** to **March 18, 2022 at 10:30 a.m.** The parties and the public may access
