**STIPULATED ORDER
EXONERATING AND RELEASING
SUPERSEDEAS BONDS**

WEYERHAEUSER COMPANY,

On or about April 22, 2003, Judgment in part in this matter was entered against defendant Weyerhaeuser Company in the amount of \$78,769,218 as to certain claims asserted by plaintiff Ross-Simmons Hardwood Lumber Co.

On July 11, 2003, defendant Weyerhaeuser Company obtained from SAFECO Insurance Company of America a Supersedeas Bond in the amount of \$83,000,000, being Bond No. 6198169, which was subsequently approved by this Court.

On October 27, 2003, this Court issued an Opinion and Order granting, in part, Plaintiff's Motion for Attorneys' Fees and Costs, and awarding plaintiffs' attorneys' fees and out-of-pocket costs in the amount of \$1,436,236.01, together with \$6,887.03 in costs.

On November 3, 2003, defendant Weyerhaeuser obtained from Hartford Fire Insurance Company a Supersedeas Bond in the amount of \$1,500,000, being Bond No. 52BSBCK8617,

which was subsequently approved by the Court.

On February 20, 2007, the United States Supreme Court issued its Opinion in this matter, vacating the Judgment of the United States Court of Appeals for the Ninth Circuit, and remanding the case for further proceedings.

By Order dated April 11, 2007, the United States Court of Appeals for the Ninth Circuit entered its Order vacating the underlying Judgment of the District Court, and remanding the matter to the District Court for further proceedings.

As a result, the Supersedeas Bonds referenced above are no longer required and should be exonerated and discharged, and SAFECO Insurance Company of America and Hartford Fire Insurance Company should be released from any and all liabilities pursuant to such respective Supersedeas Bonds.

Based upon the stipulation of the parties, it is hereby ordered as follows:

1. Supersedeas Bond No. 6198169, dated July 11, 2003, is no longer required and is hereby fully and unconditionally discharged, released and exonerated and SAFECO Insurance Company of America is hereby released from any and all past, present and future liability arising under or in connection with the issuance of such Supersedeas Bond; and


2. Supersedeas Bond No. 52BSBCK8617, dated November 3, 2003, is no longer required and is hereby fully and unconditionally discharged, released and exonerated, and Hartford Fire Insurance Company is hereby released from any and all past, present and future liability arising under or in connection with the issuance of such Supersedeas Bond.


