BIOGRAPHY

Wayne Dale Collins is Of Counsel in the Antitrust practice.

He has over 40 years of experience in antitrust law as a government policy maker, a law school faculty member, and a private practitioner. He works in all aspects of competition law but he focuses primarily on the defense of mergers, acquisitions, and joint ventures before competition agencies throughout the world. He is also actively involved in a number of antitrust litigations in the United States as well as investigations conducted by the European Commission and other agencies.

Mr. Collins joined Shearman & Sterling in 1978. In 1981, he served as a White House fellow and special assistant to then-vice president George H.W. Bush. Thereafter, Mr. Collins served as a special assistant and later deputy assistant attorney general in the Antitrust Division of the United States Department of Justice under William F. Baxter. Mr. Collins is an adjunct professor of law at the New York University School of Law and at the Georgetown University Law Center. He also has been a visiting lecturer for five years at Yale Law School, where he taught the main antitrust course and several antitrust seminars.

Mr. Collins conceived and served as editor-in-chief of *Issues in Competition Law and Policy*, a three-volume treatise that comprehensively surveys the issues facing modern competition law in the United States, Europe and around the world. For 15 years, he served as a committee chair, council member and officer in the ABA section of antitrust law and he has chaired the antitrust and trade regulation committee of New York City Bar. He is a life member of the American Law Institute and a member of the American Bar Association, the American Economic Association, the Council on Foreign Relations, the Econometric Society, and the Selden Society.
